## DEALER TERMS

### **Introduction:**

This is a Non-Exclusive Dealer Agreement Form and does not grant any Dealer exclusivity of any territory. Please review the following policies.

### **Payment Terms:**

All orders must be prepaid in full prior to shipping.

Accepted form of payment: Visa, Mastercard, Certified Check, Bank Wire Transfer, Money Order, Company Check or Cash.

### **Returned Checks:**

If a check is returned for any reason, a US \$25.00 service charge will be added to the invoice and all future order payment will be limited to Visa or Mastercard only.

### **Shipment Terms & Drop Shipments:**

All domestic orders are shipped ground unless specified by written request. All freight charges are applied to your total invoice. Taylor Made Racing will provide drop shipments of products in the continental US.

### **Orders:**

All orders must be submitted using Taylor Made Racing's website or email: sales@racetaylormade.com Upon receipt of any order, Taylor Made Racing shall promptly advise Dealer of Shipping ETA and Cost.

### **Product Price:**

Prices to Dealer are determined solely by Race Taylor Made and may be revised at any time. Taylor Made Racing will notify dealers at least 30 days in advance before new pricing becomes effective. Dealer is responsible for all taxes and duties incurred as a result of the purchase of products.

### **Back Orders:**

Taylor Made Racing's policy is to maintain back orders unless notified in writing by dealer that back orders should be cancelled. Back orders will be shipped when product becomes available with other orders or separately as prepaid shipment at Taylor Made Racing's option.

### **Damage Claims:**

Any Dealer who receives merchandise damaged during in-transit:

- i) Must notify delivering carrier's claims department immediately to settle claim.
- ii) Must not deduct the damaged merchandise from remittance.

### **Refused Shipment:**

Any shipment refused for any reason will result in revocation of Dealer's account with no further shipments. It is the company policy to charge the dealer all freight charges associated with the shipment and a 15% restocking fee.

### **Return Policy:**

All sales are final. No returns are allowed after thirty days from the day of the invoice. Dealer will be requested to pay freight on all returned items. All returns are subject to a 15% restocking fee.
